

## Borough of Walnutport Regular Meeting Minutes Thursday, May 10, 2012

- 1. Matthew Newhard, President called the May 10, 2012 regular meeting of the Borough Council to order at 7:00 pm in the Borough Municipal Building, 417 Lincoln Avenue, Walnutport, PA 18088. Mr. Newhard led the Pledge of allegiance.

Roll Call: Matthew Newhard, President; Michael Gaston, Vice-President; Joan Rehrig, Councilwoman; Harold Greene, Councilman (7:05 pm); Lamar Lauer, Councilman; William Turk, Councilman; David Stankovic, Councilman; Henry Kline, Mayor; Jason Newhard, Engineer; Michael Corriere, Solicitor; Eric Strohl, Road Foreman; Mike Wentz, Grant Coordinator (7:05 pm); Jennifer Wentz, Recreation Board Chairperson (7:05 pm); and Annette Lacko, Secretary/Treasurer.
- 3. Tom Dittmar-Environmental Conservation Coordinator, Northampton County DCED (spoke for 15 minutes) Mr. Dittmar explained e-cycling, 902 grants and offered his help with the next garbage contract. He will mail a few samples to Annette to get to Matt and Bill.
