Workshop Meeting Minutes

Thursday September 7, 2017 7:00 pm

- 1. William Turk, President called the September 7, 2017 workshop meeting of the Borough Council to order at 7:00 pm in the Borough Municipal Building, 417 Lincoln Avenue, Walnutport, PA 18088. Mr. Turk led the Pledge of allegiance.
- 2. Roll Call: William Turk, President; Harold Greene, Vice-President (absent); Joan Rehrig, Councilwoman (absent); Nancy Treskot, Councilwoman; David Stankovic, Councilman (absent); Jennifer Wentz, Councilwoman; Patrice Hunsicker, Councilwoman; Michael Wentz, Grant Coordinator; Wayne Weidner, Mayor; and Annette Lacko, Secretary/Treasurer.
- 3. Present from the public Marilyn Kaul, Bob Treskot, Ron Bauer, Danny Solderitz, & Emil Solderitz.
- 4. Opportunity for Residents & taxpayers to be Heard
 - A. Marilyn Kaul asked council a teacher in Northampton would like to purchase one of the Canal banners that hand in town. He wants to hang in his class room. He teaches the kids about the history of the canal. Patrice made the motion to give him the banner-no fee. Jen seconded the motion. Motion carried. Marilyn asked why the banners aren't hung.
 - B. Robert Treskot-tax collector wants council to adopt an ordinance about interim tax bills. Patrice advised Mr. Treskot the cost that would be to advertise, have solicitor write up ordinance, etc. Annette suggested Mr. Treskot do what he did in the past and give a spread sheet with the proposed interims to be mailed out. Annette would put on the agenda and council can approve to not specific ones to be mailed, like his example of if it is less than maybe \$50.00. All agreed.
 - C. Danny & Emil Solderitz would like to petition to have alley behind them vacated. They want to build a garage but don't have enough room. Council explained process. They will be here next week when solicitor is here. Annette will look to see if she can get them a petition.

Annette also asked the Fire Chief Mike Wentz if other fire chiefs will be sending the office a list of our residents that volunteer there. He said they are meeting and they all agreed they would.

 - i. Tree lighting-adopt a tree —the Recreation board met in August along with a few other volunteers. We are hoping to borrow the santa suite from the Diamond Fire Company and possibly having santa arrive on the fire truck about 3:00.  - ii. Jen made the motion to transfer \$1,000 that was budgeted for the recreation board to the recreation checking account. Nancy disagreed. There was a brief discussion about the recreation budget. Patrice made the motion to transfer \$650.00 from 452.000 to the recreation checking account. Nancy seconded the motion. Motion carried.
- iii. Patrice asked if she could use the pavilion on October 5th in the evening (dinner time) she and a few other moms volunteered to help feed the senior football players. They would be feeding about 45 kids. The moms will clean up after themselves. Nancy made the motion to allow the use at no fee. Mill will open the building at 5:00. Jen seconded the motion. Motion carried.
