 - TRAFFIC LIGHT IMPROVEMENTS -I submitted the reimbursement docs to PennDOT on 6/25/19 for the full \$24,000 in grant funds. I have not received any correspondence from PennDOT to date. PennDOT will reimburse \$17,600..just not engineering costs
 - LOCK 23 RETAINING WALL AND REPAIRS -We have the wetlands report completed and will be finalizing the permit submission in conjunction with FEMA's approval of the project.
 - LINCOLN AVE CDBG PROJECT -Continued from last month...We may need to reject the bids in August, if there is no commitment on additional funding. We received bids on 6/7. Two bids were received. The apparent bidder is Bellview Pump

- with a bid price of \$251,938. My understanding is that the Borough is considering applying for a matching grant to offset costs. The bids are valid for 60 days unless we need to seek funding, then they are valid for 120 days.
- MEMORIAL PARK PROJECT -We have completed a tree planting plan and submitted to Northampton County for review. We owe a revised budget to the County, which is difficult to compile due to the amount of ever-changing new donations and in-kind services to be provided by the community and contractors. It looks very favorable for the Borough to not expend very much cash toward the project completion
