# Borough of Walnutport Regular Borough Meeting Minutes Thursday July 9, 2020 7:00 pm

- 1. William Turk President called the July 9, 2020 regular meeting of the Borough Council to order at 7:00 pm in the Diamond Fire Company Social Hall 110 Main Street, Walnutport, PA 18088. Mr. Turk led the Pledge of allegiance.
- 2. Roll Call: William Turk, President; Harold Greene, Councilman; Iris Blum, Councilwoman; Michael Gaston, Councilman; David Stankovic, Councilman; Jennifer Wentz, Vice-President; Patrice Hunsicker, Councilwoman; Wayne Weidner, Mayor; Michael Corriere, Solicitor; Jason Newhard, Engineer; Michael Wentz, Grant Coordinator; and Annette S. Lacko, Secretary/Treasurer.

- 4. Opportunity for Residents & taxpayers to be Heard -
  - A. Kristie Wilk gave an update from Nova. Calls are 10.5% lower right now.
- 5. Jen made the motion by general consent to approve A-H. Iris seconded the motion.

    - Recycling contract Bids- 2021-2024- We received one bid from Cougle's Recycling Inc.

Option A: Market Rate to be based on actual market conditions and would fluctuate with market trends. \$68.00 per ton charge-floating price based upon the market and no floor.

Option B: Static Rate- is based on both historical and current market conditions and would not fluctuate with market trends but rather stay static, as listed, for the length of contracted period. \$58.00 per ton charge.

Jen made the motion to approve Option B. Dave seconded the motion. Mike-yes, Iris-yes, Harold, Patrice-yes, Jen-yes, David-yes, & Bill-yes. Motion carried.

### B. Law - Michael-

- Fireworks-complaints-will discuss with Mayor, Chief and come up with a plan to enforce
- Boat ramp- will also talk to Chief, Mayor and come up with a plan to enforce.
  - a) Council agreed to allow extra PT police officer to cover boat ramp to handle traffic issue for next few weekends until new signage can be ordered and installed. Vehicles should be ticketed and towed.

#### C. Streets -David-

- David read Mike Wentz's reports for May & June. He thanked Brian and Mike for all their volunteer time at the memorial and volleyball court. That is about 8 hours each day for each of them. Bill also thanked them for a great job they are doing.
- Tractor-snow removal- Dave made the motion to allow Mike Wentz to start negotiating a price on a new tractor for snow blowing sidewalks around borough hall. This would be for 2021 budget. The existing tractor breaks down every time they use it. Harold seconded the motion. Mike-yes, Iris-yes, Harold, Patrice-yes, Jen-yes, David-yes, & Bill-yes. Motion carried.

### D. Recreation - Jennifer-

- Walnutport Recreation Board-Jennifer

- WPA/WCA-Iris-had meeting with softball coaches. They came up with an agreement what the coaches will be doing to allow them to practice again.

- Mike Gaston asked Mike Corriere to prepare a letter to go to all nonprofits about supplying borough with total assets to borough
- Mike Gaston also asked Mike Corriere to review all the contracts with the NLRA
